Below is a description addressing how the County complied with the Citizen Participation Plan regarding citizen and non-governmental organization outreach, and any efforts exceeding GLO minimum public participation requirements:

Newton County has conducted three Public Planning Meetings, one in each of the affected areas – Burkeville (North), Newton (Central), and Deweyville (South). Newton County also conducted two Public Hearings on the Draft MOD, one in Deweyville and one in Newton.

Notices for the Public Meetings and hearings were advertised in two local newspapers in English and Spanish. The notices were also posted on the Newton County website (www.co.newton.tx.us) as well as posted at Newton County annex offices, businesses and churches in the County, and social media. Surveys for opinion of needs of the County were also made available to the citizens on the Newton County Website, annex offices, businesses, churches and at the Public Planning meetings.

Newton County will utilize the information provided by the citizens' completed surveys and information provided by FEMA to determine the best use of housing funds for residents of the most affected areas. All information pertaining to the MOD will be posted on the Newton County website.

Long-Term Planning and Recovery

Below is an explanation of how the region’s method of distribution fosters long-term community recovery that is forward-looking and focused on permanent restoration of infrastructure, housing and the local economy.

Due to the limited amount of Disaster Recovery CDBG funding available, the Method of Distribution focused on the most affected areas of the County. Discussion of the Commissioners and County Judge resulted in prioritizing the projects by assisting the most affected areas first. Priority will be established to address the most urgent unmet housing needs and then infrastructure that will help alleviate future flooding impacts. Forward-looking, long-term recovery will include a long range comprehensive master plan for the County which will identify flood and hazard resilient locations and construction standards for housing and housing related infrastructure and facilities. Long-term planning projects will be based on principles of mitigation, future resiliency and permanent restoration and improvement of community assets.

Unmet Housing Needs

Below is an explanation of how unmet housing needs will be addressed or how economic revitalization or infrastructure activities will contribute to long-term recovery and restoration of housing in the most impacted and distressed areas.

Priority will be established to address the most urgent unmet housing needs first. Unmet housing needs will be addressed by focusing on elevation, relocation, and restoration of LMI households with verified losses in the most distressed areas. Infrastructure activities will contribute to long-term recovery by improving the safety, resiliency and quality of community assets, which in turn will support future housing development in the County and long-term recovery.

The County is allocating a portion of the funds to Deweyville ISD. Newton County feels that a good school leads to the citizens wanting to stay in the community. By helping the school to rebuild, housing will be able to rebuild and grow.

Method of Distribution Detail

The County is required to prepare a method of distribution between the eligible entities or projects. The GLO has directed the County to use a direct allocation technique based on objective, verifiable data. The Method of Distribution will identify how it meets benefiting 70% low-to-moderate persons requirement., supports minimum allocation amounts that help ensure project feasibility, and provides an explanation of the distribution factors selected.

Affirmatively Furthering Fair Housing Statement

All subrecipients will certify that they will affirmatively further fair housing (“AFFH”) in their grant agreements, and will receive GLO training and technical assistance in meeting their AFFH obligations. Additionally, all project applications will undergo AFFH review by GLO before approval. Such review will include assessment of a proposed project’s area demography, socioeconomic characteristics, housing configuration and needs, educational, transportation, and health care opportunities, environmental hazards or concerns, and all other factors material to the AFFH determination. Applications should show that projects are likely to lessen area racial, ethnic, and low-income concentrations, and/or promote affordable housing in low-poverty, nonminority areas in response to natural hazard related impacts.

The County has selected the following distribution factors:

All allocations must meet or exceed a floor of \$100,000 to help ensure sufficient funds for at least one eligible project.

Eligible Activities

- Activity must be a CDBG-eligible project;
- Activity must be in response to a 2016 disaster(s)related impact in one of the following ways:
 - Direct verifiable damage from the disaster(s) that requires improvement of conditions, or
 - The facilities must have failed to function in the normal capacity as a result of the disaster(s).
- The County has added a stipulation that projects must meet a regionally-established recovery priority.

Reallocation of Funds


The county must identify the process of reallocation of funds from de-obligated funds and/or cost savings from completed projects:

If encountered, the process of reallocation of funds will follow GLO instruction and HUD guidelines. The County would propose a reallocation plan to GLO if cost-savings from completed projects occur, and if other CDBG eligible project types are identified for potential use of the reallocated funds.

If new funds are allocated, Newton County will retain the funds and will use the distribution factor of 70% for housing and 30% for non-housing.

NOW, THEREFORE, on August 14, 2017, the Newton County Commissioners' Court on a motion by William Fuller and seconded by Wesley Thompson, approve the submittal of the Method of Distribution form and worksheets related to the Community Development Block Grant Disaster Recovery Program.

Weekly Legislative Update

By James White

This past week was an exciting time at the Texas Legislature. It was the final week for legislation filed by the House to be heard on the House floor before being sent to the Senate. I was proud to lay out and pass three pieces of legislation; two that will make some much needed improvements to our criminal justice system and one to provide educational opportunities for apprenticeship training programs.

House Bill 3147 entitles a person to obtain the expunction of any information that identifies the person who was arrested solely as a result of identifying information that was inaccurate due to a clerical error or mistaken identity. Many people believe if they are released after being mistakenly arrested and the charges were dropped or dismissed without any court date being set that they no longer have an arrest record; even in cases of mistaken arrest the damaging documents are not automatically removed. This bill seeks to expedite the process of having these records expunged, so the innocent citizens who have been wrongfully arrested can move forward with their lives, free from fear of a tarnished record for a crime they did not commit.

House Bill 3705 permits juvenile justice agencies to jointly create and maintain a juvenile justice information system. Currently, 250 Texas counties and the Texas Juvenile Department are using the Juvenile Case Management System, which provides users with access to real-time information regarding children within the juvenile justice system. This bill seeks to address the way system is being used in ways that may exceed the current authority to permit the use of the system by private juvenile facilities, which makes information sharing more efficient.

House Bill 2790 looks to create funding for certain apprenticeship training programs to create more opportunities for the expansion of







Summary of Public Comments Received during Public Comment Period

Public Hearing – Deweyville High School, June 15, 2017, 5:30 p.m.

At the Public Hearing held in Deweyville, there were 37 attendees. Three of the attendees had comments, as follows:

1. When Newton County gets the money, who will distribute the money?

Response: The County will decide on eligible projects and the money will be used to fund these projects.

2. Pastor from Bon Wier: Church was damaged. A lot of people still out of their homes. Once you get the distribution, let everyone know how it works. Make sure everyone is treated fairly in the distribution of funds.

Response: Newton County will keep the citizens informed through our website, www.co.newton.tx.us, and through the local media.

3. President of Board of Trustees for Deweyville ISD: Deweyville ISD is requesting a portion of these funds. Property values have gone down. They need the money to get the new facility started. FEMA will pay 75%, but they still need the rest. He has a hard time asking for a bond from devastated people. The school is a large employer and 60% of the employees were affected. He agrees that 70% of the funds should go to helping the residents, but the school takes care of the kids, and the kids helped out during the flood. Temporary buildings are currently in use that are not sustainable. Why was Deweyville ISD not included in the survey?

Response: Deweyville ISD was not included on the Citizen Participation Survey because the survey was designed to receive responses for general areas of need such as housing and infrastructure.

Public Hearing – Newton County Courthouse, June 29, 2017, 5:30 p.m.

At the Public Hearing held in Newton, there were 54 attendees. Nine of the attendees had comments, as follows:

1. Burkeville Area: Attendee lives on FM 1414, near Yellow Bayou. Has lived there approximately 14 years, and for the past three years, SRA held water back at the dam too long. He had 3 foot of water in his house, and FEMA helped with repairs. The waterways are full of debris. Need to clean out creeks, bayous, and clean the banks so there is good flow, especially on Yellow Bayou, Big Cow Creek, and Little Cow Creek.

Response: Clearing the waterways would be very expensive. This project could be proposed to the Corp of Engineers and other organizations for assistance.

2. Deweyville Area: Attendee had the following questions/statements: A ballpark time of when the application process will begin? Need to increase income caps to help more people. There are lots of levees around Deweyville and most were washed away. This issue need to be address. Sand Pit Road had a big levee that was blown out and allows the water to flood that area.

Response: Homeowner applications may be available the beginning of next year.

3. Bon Wier Area: Attendee agreed that streams needed to be cleaned out. CR 2002 flooded again last week in the rains. Don't just hand out money, people will misuse. Get contractors to give discounts, use people on probation to work to help with labor. Money needs to stay in the County.

Response: Funds will not be directly handed out to citizens. The money will be used to fund projects approved by the County.

4. Attendee wants to know what the Floodplain Manager's job is. People were not given a tax break after the floods. Who will be doing the surveys and gathering information for the housing projects?

Response: The Floodplain office can explain their duties in full. Property appraisals are the duty of the Newton Appraisal District.

5. When can the citizens get questions answered, since questions were answered at Deweyville meeting? Can the 70% for housing include repair and rebuilding? When will the new floodplain maps be available? What is the income cap for LMI?

Response: The low to moderate income caps or income limits are established by the U.S. Department of Housing and Urban Development (HUD) which is based on household income and family size. The 2017 Newton County LMI income limits are the following:

6. Do we already have numbers for the 70/30 allocation?

Response: The proposed allocation is in the Method of Distribution.

7. President of the DISD Board of Trustees: Thank you to the Commissioners Court for allocating \$5,000,000 to DISD.

8. Attendee wanted to let the people know that her heart goes out to the people in the flood. She was not affected directly. Hopes all works out for everyone.

9. Representative James White – GLO briefs him on the progress of the grant. Explained the role of the Texas Legislature and explained he does not vote on any of this money.
10. Comment/Question via email: “I have a home that was flooded, it is not our primary home, but it was being used as a rental. FEMA could not help us, but we were able to secure a SBA loan for repairs. The issue I have with our current situation is that SBA sent out an inspector, he did a good job looking over the property, but he came up with a figure to do the repairs that seemed to be sufficient, but as the contractor got into the project, we have had to go over the loan amount. I was wondering if any of the grant money would be available for the amount exceeding the loan fund amount.”

Response: The grant funds cannot be used for reimbursement for repairs already completed.

Summary of comments received on citizen surveys and by mail:

- Six comments submitted via the surveys and one in a letter (see attached) were in reference to debris in creeks and rivers. This topic is addressed above under the Newton meeting comments, number 1.

- Many comments that roads and culverts need to be fixed.

Response: A portion of the funds allocated for non-housing will be used for infrastructure. The projects have not yet been developed.

- The remainder of the comments were emphasizing that many citizens' homes are not livable and need rebuilding or repaired.

Response: The funds allocated for housing will be used for housing related projects. The projects have not yet been developed.

- In a letter attached (2nd attachment), the citizen wants to make sure funds are utilized in Newton County and that the citizens be kept informed.

Response: The allocated funds must be used in Newton County, and HUD and GLO guidelines will be followed. Newton County will keep the citizens informed through our website, www.co.newton.tx.us, and through the local media.

Good Afternoon,

I would like to begin by saying thank you to our County Judge, Mr. Paul Price for putting this meeting together and giving us an opportunity to weigh in on the usage of the Community Development Block Grant. My name is Raquel Foster and I am a resident of the Belgrade Community in Bon Wier. I also serve as a Board Member of the South East Texas Disaster Recovery Group (SETDRG) but I am standing before you today to speak as a resident of Newton County.

Often times in disasters, those who are not affected by it directly don't realize the impact that something as unexpected as this flood will have on you. Hopefully, today I can give you a brief picture of one of the many faces of those who loss so much through this disaster. In March of 2016, my family was impacted by the flood in ways that we could never have imagined. It has affected us mentally as well as financially. Not only did we lose mementos that can never be replaced, we lost years of work that we put into our home, we lost property, we lost our savings repairing the damage to our home, we have gone into debt and one year later we are still putting the pieces back together again.

Past history, nationwide, has shown that CDBG funds tend to funnel everywhere except to the needs of the affected and to the reasons that the grant was funded for in the beginning. It is my hope and my prayer, that those who are in charge of overseeing this grant will be fiscally responsible and accountable to the people of Newton County.

My request today is that the people of Newton County will be kept updated with the process and the progression of this grant. Please do not overlook the unmet needs that this flood has created throughout our county. Also, a couple of questions, how will the affected be determined? What is the timeline of the process? How will the people of the county be kept informed? Let us work together to rebuild, repair and restore what was destroyed by this disaster.



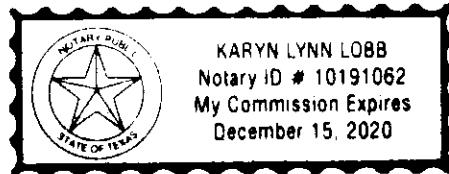
