Newton County Fiscal Year 2026 Budget Cover Page

This budget will raise more revenue from property taxes than last year's budget by an amount of \$93,276, which is a 0.90 percent increase from last year's budget. The property tax revenue to be raised from new property added to the tax roll this year is \$93,292.00.

NOTICE OF PUBLIC HEARING ON TAX INCREASE

A tax rate of \$0.703124 per \$100 valuation has been proposed by the governing body of Newton County.

PROPOSED TAX RATE	\$0.703124 per \$100

The no-new-revenue tax rate is the tax rate for the 2025 tax year that will raise the same amount of property tax revenue for Newton County from the same properties in both the 2024 tax year and the 2025 tax year.

The voter-approval rate is the highest tax rate that Newton County may adopt without holding an election to seek voter approval of the rate.

The proposed tax rate is greater than the no-new-revenue tax rate. This means that Newton County is proposing to increase property taxes for the 2025 tax year.

A PUBLIC HEARING ON THE PROPOSED TAX RATE WILL BE HELD ON September 23, 2025 AT 9:00 AM AT the Newton County Court House, Third Floor Commissioners Court Room 110 E Court St Newton, Texas 75966..

The proposed tax rate is not greater than the voter-approval tax rate. As a result, Newton County is not required to hold an election at which voters may accept or reject the proposed tax rate. However, you may express your support for or opposition to the proposed tax rate by contacting the members of the Newton County Commissioners Court of Newton County at their offices or by attending the public hearing mentioned above.

The 86th Texas Legislature modified the manner in which the voter-approval tax rate is calculated to limit the rate of growth of property taxes in the state.

TAXPAYER IMPACT STATEMENT

House Bill 1522, passed by the Texas Legislature in 2025, amends section 551.043 of the Texas Government Code to require that the notice of a meeting required to be posted under section 551.043(a) of the Texas Open Meetings Act, at which a governmental body will discuss or adopt a budget for the governmental body, must include a taxpayer impact statement showing, for the median-valued homestead property, a comparison of the property tax bill in dollars pertaining to the property for the current fiscal year to an estimate of the property tax bill in dollars for the same property for the upcoming fiscal year. Newton County has proposed a budget for the County's 2026 fiscal year. The County intends to adopt its budget on September 23, 2025.

- **2024 Value of Median-Valued Homestead Property in the County: 102,984**
- **2024 Property Tax Bill for the Current Fiscal Year (\$0.700924 per \$100 of value): \$721.84**
- **Estimated 2025 Property Tax Bill for the Upcoming Fiscal Year if the County Adopts the Proposed Budget and Tax Rate (\$0.703124 per \$100 of value): \$776.63**
- **Estimated 2025 Property Tax Bill for the Upcoming Fiscal Year if the County Adopts a Balanced Budget Funded at the No-New-Revenue Tax Rate (\$0.696645 per \$100 of value): \$734.82**

The estimates in this Impact Statement are valid only for the proposed budget and proposed tax rate that the Newton County Commissioners Court will discuss at its hearing/meeting on September 23, 2025. The proposed budget and the proposed tax rate may each be amended by Commissioners' Court before their final adoption.
