# 2020 Notice of Tax Rates in NEWTON COUNTY

Property Tax Rates in NEWTON COUNTY. This notice concerns the 2020 property tax rates for NEWTON COUNTY. This notice provides information about two tax rates. The no-new-revenue tax rate would Impose the same amount of taxes as last year if you compare properties taxed in both years. The voter-approval tax rate is the highest tax rate a taxing unit can adopt without holding an election. In each case, these rates are calculated by dividing the total amount of taxes by the current taxable value with adjustments as required by state law. The rates are given per \$100 of property value.

## **State Criminal Justice Mandate (Counties)**

The Newton County Tax Office County Auditor certifies that Newton County Tax Office County has spent \$0 (minus any amount received from state revenue for such costs) in the previous 12 months for the maintenance and operations cost of keeping inmates sentenced to the Texas Department of Criminal Justice. # Indigent Health Care Compensation Expenditures (Counties)

The NEWTON COUNTY spent \$0 from July 1, 2019 to June 30, 2020 on indigent health care compensation procedures at the increased minimum eligibility standards, less the amount of state assistance. For the current tax year, the amount of increase above last year's enhanced indigent health care expenditures is 0. This increased the no-new-revenue tax rate by 0.000000/\$100.
